In accordance with the provisions of Massachusetts General Laws Chapter 140 §137*, The owner or keeper of a dog over the age of 6 months shall obtain a license for the dog. The registering, numbering, describing and licensing of a dog shall be conducted in the office of the licensing authority in the city or town in which the dog is kept.

*The Select Board to amend Chapter 13 Article 1 entitled Dogs at Large by adding two new section;
13-6 entitled Registration and Licensing of Dogs
All dogs over the age of 6 months in the town must be licensed under MGL Chapter 140, Section 137. Licensing period will be January 1 through December 31 of each year. A late fee of \$10.00 will be charged after March 1st.
Section 13-7 entitled Removal of Dog Litter
The owner or any person walking or in control of a dog outside of the owner's or person's property shall not allow or permit such dog to defecate upon any property, public or private, unless such person shall remove all litter so deposited by such dog and dispose of same in a sanitary manner before leaving the immediate premises. This provision shall not apply to a guide dog accompanying any blind person.*
